## Section 1: Introduction

### Aim

This consultation seeks your views on proposed changes to the Plant Health etc. (Fees) (England) Regulations 2018 (SI 2018/289) and the Plant Health etc. (Fees) (Wales) Regulations 2018 (WSI 2018/1179).

Historically, the fees for plant health services delivered by APHA have been refreshed annually. However, a fees refresh (adjusting the level of fees to account for changes in APHA cost base) has not been carried out for five years, and in this time the cost base has increased substantially. This increase is partly due to inflationary increases. This consultation sets out the changes in the cost base during that time, and the proposed amendments to fees for plant health services, and the options considered. [Section 3](#) outlines specific questions that we are particularly interested in receiving responses for.

### Deadline for Responses

## Section 2: Areas for consideration

### Changes to Cost Base since 2019

A plant health fees refresh has not been conducted for five years. Table 1 below provides details of the changes in the cost base during this time.

As Table 1 outlines, there has been an increase in costs associated with the delivery of plant health services. This is primarily driven by:

- Increased number of APHA staff within the Plant Health and Seeds Inspectorate (PHSI) and Centre for International Trade (CIT) to meet increased demand for imports and export services following the UK's exit from the EU - see Table 2.
- Impact of inflation: using the CPI index, which covers both wage and price inflation, rises of circa 27% (compounded) have been experienced over the period analysed.
- Depreciation: this accounts for depreciation of costs from the new IT systems IPAFFS and PHES. These costs are apportioned between the Imports and Exports scheme (see below).
- Central overheads: these have increased in line with increases in staff numbers.

Further details of the cost base for each of the schemes are included in [Section 4](#).

## Summary of Options and Recommendation

Increases in plant health fees are required to deliver the services and to bring fees to full cost recovery. In order to achieve full cost recovery, the following increases to fees would be needed per scheme.

The cost base for each scheme have been calculated using the fees methodology agreed in 2018<sup>1</sup> and 2022<sup>2</sup> via consultation and is based on actual costs recorded over a previous 12 month period, excluding the cost base for import inspections where estimated volumes were included for fruit and vegetables (F&V) to account for the ending of the current easement on imports of EU F&V on 1<sup>st</sup> July 2025.

Inclusion of an estimated number of F&V consignments from the EU (54,865 consignments based on HMRC data<sup>3</sup>), decreases the under-recovery in the imports scheme from 32% to 27%; as the number of expected consignments increases, the percentage of under-recovery within the imports scheme decreases. It is expected that the actual numbers of consignments of EU F&V will be lower than the estimates used in the calculation of the imports cost base and that this estimate represents a 'best case' scenario for the reasons detailed below:

- Multiple lines from HMRC data may equate to one consignment (CHED). The estimation used here does not account for this and so each line is treated as an individual consignment. This is likely to result in a significant over-estimation of consignment numbers
- Some commodities fall under Commodity Codes which are 'mixed', meaning unregulated goods are likely to be included within these codes. The estimation used here counts all lines under these 'mixed' codes, meaning unregulated goods will be included, further inflating the numbers of 'consignments' seen under HMRC data

- The F&V which will be deregulated on 30<sup>th</sup> January 2025 have not been removed from these estimates. Again, resulting in an over-estimation of the number of consignments.

This gives us a range for the estimated required uplift in imports fees of between 32% (with no consignments of F&V included in the expected cost-base) and 27% (with an over-estimation of F&V consignments included in the expected cost-base). For the purposes of this fees refresh, we have taken the lower range of the cost base (i.e. an uplift of 27% would be needed to achieve full-cost recovery).

For full details of the volumes included in the Imports cost base, see Section 6.

The above increases across all schemes are significant (even when factoring in an estimated number of fruit and vegetable consignments for imports scheme) and as such, several options have been considered regarding the best way to implement these cost increases.

The following options were considered:

- **Option 1:** Increase fees to achieve full cost recovery (as detailed in Table 3 above), from around autumn 2025 (depending on when parliamentary time allows). This would result in significant fees increases in a short period of time.
- **Option 2:** Inflationary increase to fees autumn 2025 (depending on when parliamentary time allows). This would be an increase of 27.5% to capture inflationary increases from 2019-2024.
- **Option 3:** Inflationary increase introduced in two stages: one in approximately autumn 2025 ('stage 1') and the second in spring 2026 ('stage 2'). Please note these timings are subject to when parliamentary time allows. For stage 1, it is proposed that there would be a 20% increase in fees. For stage 2 (from spring 2026), the increase would be a maximum of 10%, subject to review of 2024/2025 inflation and actual costs incurred by APHA in delivering plant health services during 2024/2025. Should that cost fall below the full 30%, then the stage 2 increase would be lower. The stage 2 increase is proposed to be introduced through a subsequent statutory instrument. A period of stakeholder engagement would also be undertaken before any stage 2 changes.

Having considered these different options, we propose proceeding with **option 3 – inflationary increases introduced in two stages**. This will provide the fees increases necessary to support delivery of the plant health service, whilst easing the impact on industry by phasing it in over two stages.

In addition to the above proposed fees increases, the following amendments are also proposed:

- To amend SPCS inspection fees so that they reflect the higher costs of pre-basic versus basic crop inspections. This is because pre-basic inspections take longer, as there is a much higher walking rate than for all other grades of seed potatoes. With pre-basic crops, APHA inspectors walk a minimum of a quarter of the crop at each visit, whereas for basic stocks above 1 hectare in size, inspectors look at 0.3 hectares, irrespective of field size at each visit. Traditionally, most pre-basic stocks were below 1 hectare in size. However, this has changed in recent years, with increasing numbers above 1 hectare. For 2024, 93 of the 234 pre-basic stocks were above 1.2 hectares in size, with 34 of those 93 being above 5 hectares in size.
- To introduce an administration fee for applications to the Fruit Propagation Certification Scheme (FPCS) of £22. Previously, administration of the FPCS was undertaken by an external organisation who invoiced applicants and recovered the cost of their administration of the scheme. The management and administration of the scheme is now being undertaken by APHA again, and so, in line with Government policy on full cost recovery, a separate administration fee is being introduced to cover the cost of these activities. Since undertaking the administration of the scheme, APHA have introduced changes to ensure the process is streamlined and thus keeping costs of administering the scheme low. For example, applicants now submit one application per field, rather than grade. Previously multiple applications may have been made for the same field, so this change is saving on administration costs.
- Changes to import inspection fees to cover the below:
  - Reflect changes to frequency of inspections for certain Rest of World goods.
  - Reinstate inspection fees for *Triticum L.*, *Secale L.*, and *x.Tritosecale* after these fees were previously removed in error.
  - Updates to physical, identity and documentary inspection fees to reflect the changes to frequency of inspections for certain Rest of World goods. We consulted on this in May 2024<sup>4</sup>

Further details of the proposed fees to be included in the proposed legislation, are included in [Section 5](#).

### Imports

The imports scheme is currently under-recovering by 136% (see Table 4 above), with fees needing to be increased by a minimum of 27% (see section 2 under ‘Summary of Options and Recommendation’ for explanation of the imports cost base) to achieve full cost recovery (i.e. option 1 above). Under the proposed option (option 3), fees would be increased by 20% in stage 1 (autumn 2025), followed by a maximum increase of 10% in stage 2 (spring 2026)

In addition to the factors detailed in [Section 2](#) of this document, the changes in the cost base of import services are driven by:

- There has been a 215% increase in the number of inspections being carried out since 2019/2020. In 2019/20, APHA delivered 97,432 inspections. In 2023/24 APHA delivered 209,650 inspections.
- Hard charges and travel costs have increased in line with the increased inspection time.
- Diagnostic costs have increased in line with the increased number of inspections.
- Increased time taken to carry out documentary checks on EU imports which are often significantly larger and more complex than those from Rest of World.
- Depreciation has been included from the new IPAFFS system (as stated above)

## Exports

The exports scheme is currently under-recovering by 47%, with fees needing to be increased by 47% to achieve full cost recovery (i.e. option 1 above). Under the



proposed option (option 3), fees would be increased by 20% in stage 1 (autumn 2025), followed by a maximum increase of 10% in stage 2 (spring 2026)

In addition to the factors detailed in Section 2 of this document, the changes in the cost base of export services are driven by:

- Significant uplift in staff costs as additional staff recruited to manage increased number of export applications following UK exit from the EU
- Additional time to input phytosanitary certificates into EU TRACES NT for exports

## Plant Passports

The plant passport scheme is currently under-recovering by 26%, with fees needing to be increased by 26% to achieve full cost recovery (i.e. option 1 above). Under the proposed option (option 3), fees would be increased by 20% in stage 1 (autumn 2025), followed by a maximum increase of 10% in stage 2 (spring 2026)

In addition to the factors detailed in [Section 2](#) of this document, the changes in the cost base of plant passport services are driven by:

- Higher administration and staff costs resulting from changes related to implementation of Smarter Rules for Safer Foods, and subsequent introduction of UK (rather than EU) plant passporting.
- Higher administration resulting from changes in procedures relating to ISO accreditation.
- Increased training costs due to increases in staff numbers.
- Efficiencies introduced through revised guidance for inspectors to improve ways of working, and correction of data entry errors via IBM.

## Fruit Propagation Certification Scheme (FPCS)

Fee income in 23/24 year was £21k, largely down to seasonality factors that are normal within the scheme, this means that the FPCS is currently under-recovering by 157%, with fees needing to be increased by 53% to achieve full cost recovery (i.e. option 1 above). In determining the fee increase needed we have used a 3-year average to cushion the impact needed. Under the proposed option (option 3), fees would be increased by 20% in stage 1 (autumn 2025), followed by a maximum increase of 10% in stage 2 (spring 2026)

The cost base of FPCS services has remained relatively stable over the past five years, it is income that often fluctuates. The scheme is relatively small and has been largely unaffected by impacts on other areas, such as EU exit, hence why the cost base remains stable.

## Seed Potato Classification Scheme (SPCS)

The SPCS is currently under-recovering by 40%, with fees needing to be increased by 32% to achieve full cost recovery (i.e. option 1 above). Under the proposed option (option 3), fees would be increased by 20% in stage 1 (autumn 2025), followed by a maximum increase of 10% in stage 2 (spring 2026).

The overall costs of SPCS have decreased. This is due to a decrease in areas requiring certification. However, the length of time taken to carry out inspections has increased, which is not reflected in fees recovery as these are charged on a per hectare basis. This is due to an increase in area of pre-basic stock requiring certification which takes significantly longer to inspect.

## Scientific Authorisations

Fee income for 23/24 year was £59k meaning that the scientific authorisation scheme is currently under-recovering by 97%, with fees needing to be increased by 79% to achieve full cost recovery (i.e. option 1 above). In determining the fee increase overall we have used a 3-year average for the volumes associated with Authorisations. Under the proposed option (option 3), fees would be increased by 20% in stage 1 (autumn 2025), followed by a maximum increase of 10% in stage 2 (spring 2026)

In addition to the factors detailed in [Section 2](#) of this document, the changes in the cost base of Scientific Authorisation services are driven by:

- Efficiencies introduced by reducing level of information needed to be supplied (where this did not impact on biosecurity) has resulted in time savings as requirement to chase applicants for additional detail has significantly reduced.
- A review of authorisations is underway. This will remove fees for some authorisation holders, by ensuring that any material that does not need to be held under an authorisation is not held under an authorisation.
- Applicants are able to apply for several changes to their authorisation at the same time, which reduces costs.
- Applicants are contacted in advance of compliance visits to inspect new facilities at the same time and save on travel costs.
- Authorisations of the same type have been combined at sites where this is possible, to save administration and fees.
