Provisional Protocol - International Representation and Coordination

Principles

- The purpose of this protocol is to describe how coordination of UK positions at international fora is achieved and what national expertise is required to represent the UK at these fora.
- Vacant posts and UK representatives from Defra, DAERA, Scottish
 Government and Welsh Government will be agreed by the PVSC and, where
 necessary, with the assistance of the NLSC.

Protocol

- For each international meeting attended, the relevant lead representative for that meeting is responsible for organising a pre-meeting with UK colleagues and experts to agree the UK position at a suitable time and at least one week ahead of the meeting.
- 2. The lead representative will ensure that relevant papers are circulated/made available ahead of this pre-meeting when they become available.
- UK positions and comments are agreed in these pre-meetings in accordance with the policy direction set by the PVSC and the technical advice provided by the NLSC and relevant technical sub-committees, ahead of UK participation at the international fora meeting.
- 4. Papers to be agreed by correspondence (instead of via a pre-meeting) will be sent to PVSC members or their relevant nominated person in a timely manner to allow for comments to be submitted.
- 5. After the international meeting, the lead representative is responsible for ensuring suitable reporting back, within 10 working days, on the outcome of the meeting usually in the form of a meeting report to be circulated to, at least, the PVSC and NLSC and other suitable colleagues from Defra, DAERA, Scottish Government and Welsh Government with relevant interest.
- 6. Representation at these meetings is provided by delegates from the relevant authorities in the UK with suitable expertise determined by the NLSC or PVSC where appropriate as described in the following table. If there is more than one representative attending the meeting, then a lead representative will be agreed ahead of attendance.

- 8. If any additional meetings, to those described in the table in point 6, are attended, the UK position is agreed as in points 1 to 4 above and reporting back as in point 5.
- 9. Attendance is funded by the Authority the representative belongs to 1. Opportunities should be made available for additional colleagues to attend in a training capacity, especially in instances of hybrid and virtual meetings that could allow for upskilling without any significant increase in costs.
- 10. The acceptance of an offer to host in the UK any of the meetings described in the table in point 6 shall be notified to the PVSC and NLSC and efforts made to ensure all participants can have representatives at any relevant UK held international meetings.
