## UK plant breeders with Retained EU Plant Variety Rights: important information

In January 2024 we issued a formal request to holders of Retained EU Plant Variety Rights to provide an address for service in the UK or details of a UK agent. This information is legally required by the Controller of the Plant Variety Rights Office<sup>1</sup>. **please provide us with this information, following the instructions below (please note that the email address for correspondence has now changed to [pvs.helpdesk@apha.gov.uk](mailto:pvs.helpdesk@apha.gov.uk)).**

**If you do not provide an address for service in the UK or details of a UK agent, your Retained EU Plant Variety Right(s) may be at risk of termination in the future.**

### What you need to do

If you hold Retained EU Plant Variety Rights, you will need to provide us with additional information relating to those rights for their remaining lifespan. Please email [pvs.helpdesk@apha.gov.uk](mailto:pvs.helpdesk@apha.gov.uk) as soon as possible with:

**1. Confirmation that you hold Retained EU Plant Variety Rights** and want to continue to hold these rights for their remaining lifespan.

**2. Confirmation of the varieties you want to continue to hold rights for**

- Open the spreadsheet below and find your name in column H (we have sorted the data alphabetically). Please note this spreadsheet is the original list provided to APHA by the CPVO before amendments and will contain Retained EU Plant Variety Rights that have since expired.
- Fill in details for each of your rows by stating ‘Yes’ in column H for those varieties you want to continue to hold rights for, fill in today’s date in column I and add the date on which you filled in the PSV11 form (mentioned in point 3 below) in column J.
- Copy and paste the rows in your section including columns A to J into a new spreadsheet and attach it to your email. For ease of filtering the data has been sorted and is listed by the Holder of Rights – please see the example below.

- Include your UK address for correspondence.
- Tick the second tick box that says 'the Controller of Plant Variety Rights in accordance with the Plant Breeders' Rights Regulations 1998;'
- Leave the table with Species/Breeders ref/AFP number blank.
- Fill in your name underneath the table where it says 'Name in BLOCK letters (no need to complete your signature)'
- Click on 'Lock this form' and then save a copy of the form to attach to your email.

### 4. Details of any changes to ownership of Retained EU Plant Variety Rights since 31 December 2020

If you have taken on ownership of a Retained EU Plant Variety Right from someone else, you will need to complete the PVS10 form below with your details. Please then attach this to the email.
