The fees set out in Table 1 will be included in legislation due to come into force on 1st June 2021. The fees will be applicable from 1st June and apply to the high priority goods, currently subject to controls, imported into England and Wales from EU member states, Lichtenstein and Switzerland. All consignments will be subject to documentary checks charged at £5.25.

Similar arrangements are in place for Scotland but note the fees structure will vary.
